General Warranty for Standard APCO Interior, Non-Illuminated Products

LIMITED WARRANTY: Standard APCO Interior Sign Products are sold with the understanding that the Purchaser has independently determined the suitability of such products for its purposes.

Standard APCO Products are warranted to be free from defects in material and workmanship for a period of one (1) year from date of shipment from our manufacturing facilities in Atlanta, Georgia USA.

During this period, any standard APCO product shown to the satisfaction of APCO to be so defective, will be replaced without charge, or APCO may issue a credit in such amount as it deems reasonable; however, in no event shall APCO be responsible for claims beyond the replacement value of the defective product or in any way liable or responsible for incidental or consequential damages of any kind, indirect, special, nor for labor, removal or installation costs.

This Limited Warranty *does not* cover losses that occur as a result of:

- Shipping, improper installation or maintenance.
- Misuse or neglect.
- Normal wear and tear.
- Vandalism
- Repair or modification by anyone other than an APCO representative or employee.
- Products that you or any third party modify or alter, in which case you bear the sole responsibility and liability for any such modification or alteration.
- Placement of ADA Process 1 products, photopolymer or phenolic, in an environment where temperature and humidity are not controlled at all times

EXCLUSIONS: This warranty covers only standard APCO products manufactured in USA by APCO Graphics, Inc.; sold and in use within the continental United States, Alaska, Hawaii, Puerto Rico, and Canada.

NOTICE AND INSPECTION: If you believe the installed product may qualify for warranted defects, you may return the product, along with dated proof of purchase, to APCO GRAPHICS, INC., 388 Grant Street, SE, Atlanta, GA 30312 USA, Attention: Warranty Services. Prior to returning any product, the Purchaser is required to telephone for authorization.
